They should have level of English proficiency sufficient for successful development of the program. While, availability of the official documents on successful passing TOEFL or IELTS could be the basis for their priority enrollment to EP. Candidates responding the abovementioned requirements are taken to the program by the results of entrance tests and the interview conducted in English.
